We don't know who the strike target will be or what strategy the International Union will take. We do know if our members are prepared for any scenario, we will get a better deal!

FINANCIAL SECRETARY REPORT

Greetings Local 14 UAW Members,

The RBC Bank account balance on 6/30/2023, was \$2,753,054.28. The book value on 6/30/2023 was \$2,690,511.75. The actual value was \$62,542.53 higher than we can report in the Financial Statement. This is our unrealized gain, and if we cashed in our investments on 6/30/23, our payout would have been \$2,753,054.28.

Congratulations to all members that ran for a position in the elections. It's tough putting your name out there, and everyone is a winner rather you were elected or not. We elect members to make decisions for the full membership, and we work together to be good stewards of your money.

In February 2023, the International Union increased the strike pay from \$400 to \$500 a week. The increase was made because of rising inflation and the need to prepare for an important bargaining year.

If disputes arise during negotiations of our contract, the International Executive Board may issue a call for a strike vote. The members in good standing with Local 14 will be given due notice of a vote to be taken by the membership. It requires a secret ballot of two-thirds (2/3) majority vote of the voting members, to request a strike authorization from the International Executive Board. Only members in good standing with Local 14 will be entitled to vote.

Local 14 must follow the strike guidelines stated in the Constitution, including authorization for a strike from the International President and/or the International Executive Board. If these guidelines are not followed, Local 14 will not have any claim for financial or organizational assistance from the International Union or any affiliated Local Union. The International Executive Board, working with the Region 2B Director, will let Local 14 know when a strike is called off and when we can return to work.

The following is a summary of the most recent Strike and Defense Fund for the month of May 2023; Income was \$5,909,102.79 with disbursements of \$2,872,920.54. The balance at the end of May was \$838,456,570.54. During the month of May there were four strikes. The International Union does not specify who was on strike nor do they itemize the income or expenses.

EDUCATION TOGETHER WITH CIVIL AND HUMAN RIGHTS

To open, we collectively send thanks to everyone that was on the ballot this election. It is not an easy thing, but we as union people always get things done. This is a jointly written article that we submit to you, our membership and family for your consideration.

It is only through our active involvement and engagement that we are able to better our union. That being said, this committee is mandated to make sure that all members and leaders get the education that they would need to be strong members of the labor movement. This committee was one of the first committees established in 1935 and then at our first Constitutional Convention in 1936 it was mandated. In our general course, UAW 101, we tell everyone that to be a strong member and speak with knowledge you should have three things: Constitution, Union Bylaws, and your National Agreement. These are the three things that hold our foundation. This year is no different, but contract years are always ones that tend to be more challenging thereby reinforcing that bit of knowledge. We train every new member that enters our facility, and this can only be done through collective bargaining.

As we look to our future, we must also look to all our members. We are only as strong as our weakest member. Every committee here at Local 14 looks for new members and this committee is no different. We look to have a Young Workers Committee so that we can reach our younger siblings to make sure they are getting the union education they need. This, along with organizing, is where we are looking to grow. We truly need to grow our committee and all our committees. A union cannot flourish on the energy of its members when the roster of each committee reads the same. The Education Committee needs new members to get the mandated Organizing Committee off to a great start for our Local. What will this take you may ask? It will take nothing less than a broad spectrum from all our members, including retirees, TOP, GM, and DFM alike, to get this off to a great start. The thought here should be one thing, there is no reason a CEO should be making 425 times the rate the member making their product brings home. No matter

how much more they do make, one thing is for certain, they will always put profits before people and unless there is strong language in our contracts, they will continue to push us to the side. It did not happen in Walter Reuther's day, today or in the future.

In these past terms, it has been great working with all our members and the Unit Committee looks equally forward to working on growing and improving through joint efforts. During our education classes one of the things that we do as education is speak to our UAW endorsed constituency groups of the AFLCIO. These groups would include the NAACP, Pride at Work, A Philip Randolph Institute (APRI), Coalition of Black Trade Unionists (CBTU), Asian Pacific American Labor Alliance (APALA), Labor Council for Latin American Advancement (LCLAA), Coalition of Labor Union Women (CLUW). The Education and Civil and Human Rights Committees formed the foundation of our union.

During our education class on core values, we speak directly to Civil and Human Rights about equality. Using the two of the three tools we spoke about earlier, we can identify this in the Constitution Article 2 Section 2, gives us why we are all equal and, in our contract, it is laid out in Paragraph 6 and 6a. The language in both the Constitution and our Collective Bargaining Agreement have grown over the years, but the foundation was laid out through the actions of our great leader Walter Reuther. We see him in so many pieces of history and

my personal favorite is the march on Washington. Let's not forget this speech was written at Solidarity House and delivered on June 23, 1963.

Companies recognize the force of the UAW with Civil and Human Rights, even those without a union. Most of all, almost all companies now have departments of diversity, equity, and inclusion. The department's goal is to bring members together to a common forum and make sure that they feel valued and included in a diverse workplace. This sounds like Civil and Human Rights to me. We are no different, and for us it is about working together jointly to get to a common goal.

As leaders of the Civil and Human Rights Committee members, we are the essential guardians of the "No Discrimination" policy of our union. As I mentioned before, we are here to ensure that Article 2 Section 2 of our Constitution is given the respect to which it should receive. We

are here to work along side the elected committee people of all districts in upholding and assisting where members feel there has been a violation. 
Hello everyone!




