New Officers Take Oath at July Local 14 Meeting

Following the Local 14 elections on June 21, newly elected and returning officers met at the Amalgamated meeting on July 30 to take the oath of office.

Taking the oath of office were newly elected Local 14 President Dennis Earl, Vice President Edd McNulty, Recording Secretary Lori Schultz, Financial Secretary-Treasurer Sue Rodgers, Recreation Director Ryan Lukasik, Education Director Arthur Espinoza, Sr., Guide Jamele Perry, Sergeant-at-arms David Ringle, and Trustees Maria Braman, Ryan Baughey, and Jamaal Kirby.

Dennis Earl thanked the membership for their support and pledged to work with the members on a daily basis to keep Local 14 growing and improving. "It is a real honor to be allowed to serve this great membership," he said.

He also urged members to keep attending meetings, get involved in the union's activities, and make their opinions known on social and political issues so that the union can keep moving forward and do what it needs to do. "I hope to always be guided by your best interests," he said. "I need

Local 14 President Emeritus Oscar Bunch said, "We've got a bright future here, probably the best in General Motors. We're going to keep growing." He noted he had met with a lot of GM officials over the years, and they all brag about Toledo. He also noted that a proposal to cut the hours of the Financial Secretary-Treasurer to 20 per week was unnecessary and counter- productive. We sure don't need any changes here," he said.

Other speakers discussed this by-laws change before it was voted down by the membership by an overwhelming majority. One member commented, "If it ain't broke, don't fix it."

Members also addressed issues including pay for temporary workers at the Oscar Bunch UAW/ GM Powertrain Park and the use of paper ballots in deciding issues which come up at the meetings.

Earl also discussed the many committees which Local 14 has, noted that he will be working with committee chairpersons in upcoming weeks to update committee efforts, and urged interested members join the committees and make their voices heard.

Financial Secretary-Treasurer

Dear Local 14 Brothers and Sisters:

The fall weather seems to be approaching and soon the leaves will turn beautiful colors. The kids will carve pumpkins and take hay rides through the apple orchard. Fall is a beautiful time of year and I hope you have the chance to take advantage of the beauty it brings.

When I campaigned for this

job I talked about creating a membership survey to find out what Local 14 members want out of their union. The survey is complete and will be distributed to the full membership. Please take some time to fill this out. We want your ideas, suggestions and comments. This is your union. Help us build it and create a future that benefits the membership.

Our Merrill Lynch actual account balance on 8/31/17 was \$2,953,157.10 and the book value was \$2,864,098.89. The actual value on 8/31/17 was \$89,058.21 more than we can report on the financial statement. This is our unrealized gain and if we cashed in our account at the end of the month we would be paid \$2,953,157.10. The monthly gain for August was \$4,416.03

and the year to date gain was \$170,724.57.

This past Sunday we held the annual Park N Shine at the Oscar Bunch Park and took donations to help offset the cost of workers in the park. The new Executive Board made this decision but the event was planned and advertised long before they were established. The collection brought \$567.08. In the future we will make sure the event is publicized in advance that we are accepting donations. Thank you everyone who helped with the collections.

Our light bill for July was \$1,825.31 this was higher than last year, so I had a conversation with everyone that uses this building including the maintenance and office staff. I explained the importance of controlling costs in this building for the best interest of everyone.

I had a meeting with Merrill Lynch and we discussed our current investment package to make sure we are earning money and to see if we have any options to expand our investments but stay within the International guidelines. As you can see our current package is making a good amount of money and we agreed to stay with this for now.

Guardian Alarm trained me on the use of cameras and security system for the building. Dennis and I met with Huntington Bank and removed all old names on the account and replaced them with ours. We also discussed that they remove charges for stop payment fees on checks. This was done and I am currently working on removing monthly service charges from the account.

We have several organizations and charities using the building on a daily, weekly and monthly basis with little or no cost. I have put this on the Executive Board Agenda to review and discuss at this month's meeting. I will keep the membership informed on the decisions they make on this and all future plans.

In June we had some wind damage and lost some of the siding on the back of our building in the bar area. We contracted SMB Construction to do the work and our insurance company covered the \$16,000.00 cost. We paid the deductible of \$1,000.00. We recovered the old aluminum siding and received nearly \$300.00 to use toward the deductible. The work is complete so if you have a chance, stop by and take a look at it.

The brackets for the two glass entry doors to the upstairs hall were bent so I went to North-

wood Door and purchased new ones for \$40.00. The maintenance man installed the brackets saving the union \$250.00 for a service call.

Throughout the year we incurred problems with the air conditioners for the upstairs and downstairs hall. The work was contracted with Dimech Services. After conversation with our maintenance and reviewing the past invoices they overcharged us for May repairs. I spoke to the owner of Dimech and they agreed we pay for parts only on this repair saving our union \$909.00. We also had repairs in July on a separate unit and I arranged to pay for parts only on this saving our union an additional \$1,100,00.

Our website will soon have a new look and will reflect the International Union site. This will provide the membership with more information and I think it looks more inviting than the old one

The annual event known as the "Clam Bake" will be held on September 30, 2017 at the Tam O' Shanter in Sylvania, OH. Local 14 membership voted to purchase and reserve 20 tickets on a first come basis, they are available at the door. This includes free food, music and games for the kids. We do not have tickets available at the Local 14 Union hall. The region puts this on and has handled this event the same way for years.

Thank you for your patience during this learning period of my new position. I appreciate Local 14 membership and feel it is a privilege to be of service to you. I work for Local 14 membership and with your help we will build your future of this union. Please call upon me for any of your needs.

I am currently an electrical apprentice and I am attending Owen's Community College to earn my Journeyman's Card. I look forward to serving my Local and the membership.

I must give my thanks and gratitude to several people for their assistance with the Park and Shine this year. Dawnya Ferdinansen, Jim McGill, Ryan Baughey, Kim Baughey and Jamele Perry; these 5 volunteered their time to man the Education and Union Label Booth as well as helping to sell raffle tickets. Thank you all very much for your help, without it we would not have been as successful.

The Education Committee hit the ground running this year joining with other committees

from both the local and the unit collecting school supplies and funds in excess of \$2000 for local area students. We set up a booth with other committees to pass out union made chips, candy and bottled water to the Park and Shine attendees and sold 50/50 raffle tickets. We would not have been able to achieve this if not for the other committees. We will start buying supplies and assembling book bags soon. We have several requests from local area schools to provide much needed school supplies for their students.

Moving forward, it is our intention to work with the other committees as often as possible, working as a union, not as separate committees, to increase union awareness and participation in our community. Common goals we all have is that we want to correct the mistakes of the past, provide a future for our membership and work together to achieve more. 



Here is a brief Origin and History of the Union Label

The invention of the union label concept is attributed to the Carpenter's Eight-Hour League in San Francisco, California which adopted a stamp in 1869 for use on products produced by factories employing men on the eight- (as opposed to ten-) hour day. In 1874, that city's unionized cigar-making workers created a similar "white labor" label to differentiate their cigars from those made by poorly paid, non-unionized Chinese workers. The concept of the union label as a tool for harnessing support from fellow working-class consumers for unionization spread rapidly in the next decades, first among the cigar makers (their union adopted the first national union label in 1880), but among other unions as well, including typographers, garment workers, coopers, bakers and iron molders. By 1909, the American Federation of Labor had created its Union Label Department.

Our Union Label committee had a chance to participate in the Toledo Labor Day Parade. Lenette Holden, UL Secretary, and I designed our banner. Gwendolyn Yarbrough Gordon, Frank St. Amour and myself had a chance to drive in the parade

with our UL banner proudly displayed for all to see. Many people at the parade waved and yelled, "Hi Local 14 Union Label. Look for the Union Label"



Different ways to have your voice heard

It's always important to know what our leadership's message is. Their ability to communicate a clear goal and how we as a union can execute the goal often determines whether or not we will be successful. Our leadership can't do it alone, they need all of our help. Our input matters and helps shape the direction of where we are going as a union. The following are ways to let our leadership know your concerns on issues that affect us

· Attend union meetings-This is the best way for us to talk about our issues collectively and try to come up with an understanding of where we are at and how we want to go forward.

- Put in a committee call- If you have an issue with what's going on or are concerned about what might happen put in a call to voice your concerns.
- Contract Demands- During contract time put in a demand and try to make it more than a one liner. Explain in more detail what you want and why. This is an opportunity to add or delete something in the two contracts. Remember there are local demands that are for our facility and national demands that effect all facilities.
 - All employee meetings-

Ask questions at all employee meetings of management. Its better when we all hold them accountable for their actions.

- Surveys- Sometimes there are surveys that go out to see how our location is performing. take this time to let management know.
- Team Meetings- Team meetings are a good way to talk about what affects us on a daily basis. This is a good time to build consensus amongst your team to amplify your voice.
- LEAD Topics- When a LEAD topic comes out talk to your learning leader. Let them know what you think about it. Your input is shared with local leadership and a report is sent to the international union whenever there is a LEAD topic.

The union is only in existence because our founders spoke up and took action. Don't let your voice be muted. Speak up through these various channels and we will be even stronger because of your efforts!


