- 2. TEAMS MAY ENTER MORE THAN ONCE BY CHANGING ONE BOWLER, DOUBLES MUST CHANGE ONE BOWLER, SINGLES MAY ENTER ONLY ONCE.
- 3. HIGHEST, 2016-2017 USBC AVERAGE MUST BE USED.
- 4. IF ENTRANT DOES NOT HAVE ESTABLISHED AVERAGE IN LAST THREE (3) SEASONS SUCH ENTRANTS COULD USE THEIR HIGHEST USBC SANCTIONED CURRENT SEASON AVE.

 BASED ON 21 OR MORE GAMES AT TIME OF BOWLING. (WOMEN WITH NO AVERAGE BOWL AT 165. MEN WITH NO AVERAGE BOWL AT 180)
- 5. TOURNAMENT COMMITTEE WILL ASSIGN LANES PRIOR TO BOWLING.
- 6. BOWLERS MUST BE MEMBERS OF USBC. BOWLERS WHO ARE NOT MEMBERS MAY QUALIFY FOR ENTRY AND ALL USBC SERVICES BY PAYING AN AFFILIATE MEMBERSHIP FEE OF \$16.00 USBC PRIOR TO BOWLING (RULE 300) ANOTHER OPTION IS TO PAY A PARTICIPATION FEE OF \$5.00 USBC WHICH ONLY ALLOWS THE BOWLERS TO ENTER THE TOURNAMENT, BUT NOT QUALIFY YOU FOR ANY USBC AWARDS.
- 7. IT SHALL BE EACH BOWLER'S RESPONSIBILITY TO VERIFY THE ACCURACY OF HIS OR HER AVE. ORIGINALLY SUBMITTED BY THE BOWLER, HIS TEAM CAPTAIN OR OTHERS. FAILURE TO USE THE PROPER AVE. OR MAKE A CORRECTION UP TO 48 HOURS AFTER THE TOURNAMENT ENDS, SHALL DISQUALIFY SCORE SUBMITTED AVE IS LOWER THAN ACTUAL AVE. OR BASE PRIZE WINNINGS ON SUBMITTED AVE. IF IT IS HIGHER.
- 8. POSITIVELY NO REFUNDS. AFTER CLOSING OF ENTRIES.
