Team Effort Required to Reduce the Risk of Coronavirus

The last few weeks we have hear a lot about the Corona virus situation. I want to ask you to take some time to review the information below to understand the measures we are taking to protect our employees.

The health and safety of our employees remains GM's overriding priority. As the coronavirus disease 2019 (COVID-19) outbreak continues to evolve and spreads globally, GM Medical and Security are monitoring the situation closely.

All employees are REQUIRED to observe a 14-day isolation period prior to entering a GM facility if they meet any of following criteria:

1. You are returning from, or have had a layover in China, South Korea, Iran, Japan, or Italy. The 14-day isolation period starts the day after leaving the listed country.
2. You have had close contact with or cared for someone diagnosed with COVID-19. The 14-day isolation period starts the day after last contact or if you are providing care once the individual recovers.

So what does this mean in our manufacturing plants?

If you meet the above criteria, you need to inform your leader and HR/LR. If it is before your trip, you can contact them by person. If you are returning from travel, please call.

On completion of the isolation period, if you remain symptom free, you may return to work without further action. However, if you develop symptoms such as fever, cough, difficulty breathing, cold symptoms (sore throat, congestion, runny nose), or diarrhea during the isolation period you must seek medical care. Please let your physician know where you have traveled and/or come in contact with COVID-19. Do not return to work until your personal physician verifies you are no longer contagious.

Every team member must know what the WPO manual is, where to find /access it, who owns it & how to get it changed.

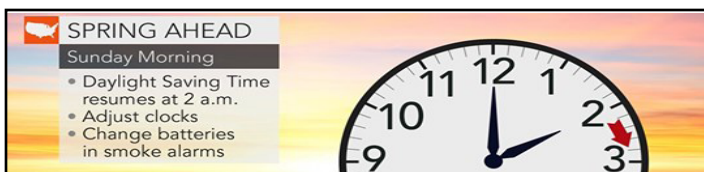
Where is it? The WPO manual is located in the General Plant Training Stand – located near your team room (pic#1) or on the TOLEDO sharepoint site (pic#2)

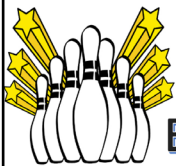
