## Aaron James Lee wins Gosser Scholarship



### Local 14 Member's Stepson Wins Gosser Award

Aaron James Lee, stepson of UAW Local 14 GM Powertrain member William Young, has been awarded a Richard T. Gosser Scholarship.

The award was presented at the 57th annual Awards Luncheon at Region 2B Hall.

Aaron is a senior at Oak Harbor High School. In addition to regular high school courses, he took several musical courses including jazz band and band choir. He also was captain of the football team, and track. He plans to go to Ohio Northern University where he will study pre-law.

Mother Jennifer and stepdad William Young praised Aaron for his work ethic. Jennifer said, "We're proud of all his accomplishments, and the work and effort it takes to apply for all these scholarships and go through the process, we're just very proud of him." Stepdad William Young said, "He always exceeds expectations. He never ceases to amaze me."

Aaron said, "I appreciate my parents and the way they have supported me all the time."

His grandparents, Sheila and Ron Powell, who also attended the luncheon, pointed out he took advanced classes throughout high school, adding their pride in his accomplishments as well.

In a note, his principal Cheryl Schell wrote, "Aaron is ranked 14th in his class (of 131 students). I have seen this young man excel in the classroom, on the athletic field and on stage in musical performances while also holding down a part time job washing dishes. Aaron is a well-rounded and outstanding student who has maintained a 3.98 GPA during his time at school. He also

has set aside time to volunteer in the school and in his community. Aaron Lee is the best of what Oak Harbor High School has to offer."

Addressing those assembled at the luncheon, Aaron said, "Thank you very much for this opportunity. I would like to thank the UAW for providing this scholarship. Not only are they investing in education, they are investing in the future of society. Education is the pathway to finding new ideas. I would like to thank my family for supporting me. It's great to have such a backbone to support me."

He also praised his school and school system. In addition, he praised unions in general. "It's nice to know in a time where corporations have such power, because of unions, my stepdad will be working for a fair wage and for fair hours."

Twelve high school seniors from Region 2B UAW families received \$10,000 college scholarships by the Richard T. Gosser Scholarship Awards Program. The Gosser Scholarship Awards Program, named in honor of the late UAW Vice President and Regional Director, Richard T. Gosser was established in 1962.

This year, eight scholarships were awarded in the name of Richard T. Gosser and one scholarship each were awarded in the name of Ruthann Gosser-Harrison, Joseph Tomasi, Jack Sizemore and Lloyd Mahaffey.

Including the 2017-2018 winners, 344 students have received Richard Gosser scholarships. An additional 125 students have received runner-up scholarships. In all, \$2,602,000 in scholarships have been awarded since the program began in 1962.

## Social Security News

# How the work rules work for you

Retirement doesn't have the same meaning for everyone.

Some people plan to retire and never work again. Some people plan for second careers in occupations that wouldn't have adequately supported their families, but they do the work for pure enjoyment. Some people, whether by design or desire, choose to work part-time or seasonally to supplement their retirement income.

Retirees (or survivors) who choose to receive Social Security benefits before they reach full retirement age (FRA) and continue to work have an earnings limit. In 2017, the annual earnings limit was \$16,920 for those under FRA the entire calendar year.

In 2018, it is \$17,040. If you earn over the limit, we deduct \$1 from your Social Security monthly benefit payment for every \$2 you earn above the annual limit.

In the calendar year you reach FRA, which you can check out at

[www.socialsecurity.gov/planners/retire/ageincrease.html](http://www.socialsecurity.gov/planners/retire/ageincrease.html).

You have a higher earnings limit. Additionally, we will only count earnings for the months prior to FRA. In 2017, the limit was \$44,880. In 2018, it is \$45,360. In the year of FRA attainment, Social Security deducts \$1 in benefits for every \$3 you earn above the limit.

There is a special rule that usually only applies in your first year of receiving retirement benefits. If you earn more than

the annual earnings limit, you may still receive a full Social Security payment for each month you earn less than a monthly limit. In 2018, the monthly limit is \$1,420 for those who are below FRA the entire calendar year. The 2018 monthly limit increases to \$3,780 in the year of FRA attainment.

Once you reach FRA, you no longer have an earnings limit, and we may recalculate your benefit to credit you for any months we withheld your benefits due to excess earnings. This is because your monthly benefit amount is calculated based on a reduction for each month you receive it before your FRA. So, if you originally filed for benefits 12 months before your FRA, but earned over the limit and had two months of Social Security benefits withheld, we will adjust your ongoing monthly benefit amount to reflect that you received 10 months of benefits before your FRA, and not 12.

Most people understand that if they work while receiving benefits before FRA, their benefit may be reduced. What most people do not consider in their retirement planning is that we recalculate your Social Security monthly benefit at FRA to credit you for Social Security benefit payments withheld due to earnings over the limit. Explaining the earnings limit is another way that Social Security helps secure your today and tomorrow.

Understanding both the earnings limit and the possible recalculation of your ongoing Social Security benefits will provide an additional perspective on retirement for you to consider.

## Financial Secretary-Treasurer

The Merrill Lynch account balance on 4/30/18 was \$2,846,987.48.

The book value on 4/30/18 was \$2,787,336.49 and the actual value was \$59,650.99 more than we can report on the financial statement.

This is our unrealized gain and if we cashed in our account at the end of April our pay out would be \$2,846,987.48.

Congratulations to Aaron Lee the winner of a \$10,000 Richard T. Gosser Scholarship offered to UAW Region 2B family members. Aaron is the son of Bill Young a Local 14 member working second shift production in the plant. Aaron is one of twelve outstanding high school seniors from Region 2B UAW families to win a \$10,000 Gosser Scholarship this year. This scholarship program was named in honor of the late UAW Vice President and Regional Director, Richard T. Gosser and was established in 1962. Since the program started in 1962, \$2,602,000 in Gosser Scholarships have been award-

ed. We are very proud to have one of our very own win this prestigious award. If you would like more information for next years' program please visit the UAW Region 2B website; [www.region2b.uaw.org](http://www.region2b.uaw.org).

Our light bill for the month of May was \$632.88 and the gas bill was \$723.79. On the weekends the thermostats are programmed based on the length of time the renter is in the hall and it will shut down at the end of evening. Last year the winter months gas bill averaged \$1,200.00/month.

We had 31 white "Lifetime" plastic chairs that were broken. After some research I found the tables and chairs were under a ten year warranty. "Lifetime" arranged to pick up the broken ones and delivered 32 new ones at no cost. This was a savings of approximately \$950. The remaining chairs in the hall were inspected and 47 more were broken. I have made arrangements to get new replacements from the vendor at no cost to us, an additional savings of nearly \$1,500.

The hall had a couple of leaks in the roof near the kitchen, the roofing contractor patched the leaks. We checked the roof after all the rains and found it was still leaking in the same spots. The manufacturer contracts the roofing contractor and they will be out this week to get it fixed. The rubber roof was installed in 2009 and holds a 20 year warranty.

We have a lease agreement with Local 58G the grain millers. They rent a small office off the Solidarity Room and use the meeting hall once a month for union meetings. The Local 14 Executive Board met and decided to renew their lease for two years. The past rental amount was \$100.00 per month and after figuring out our costs the renewal will be \$225.00 per month. Local 58G was pleased with the amount and signed two more years with us.

I will continue to keep you informed on the monthly hall rentals in this building. In the month of April the upstairs hall was rented 8 times and the downstairs was rented 9 times.

The rental of our voting machines from Electec Election Services, Inc. was a cost of \$7,698.00. This price includes the rental, set-up, three technicians and delivery. I was able to negotiate a 5% discount so the final invoice was \$7,313.10.

I have the LM2 and 990 Tax returns for 2017 completed. The LM2 tax return is 45 pages long and the 990 tax return with all

the schedules is 15 pages long. The returns are required to be filed annually with the U.S Department of Labor. Since 2011 the returns are completed and filed annually by the Local 14 Financial Secretary. In prior years the tax returns and 6 month audit was done by an outside firm and cost Local 14 approximately \$11,000 per year.

Local 14 halls are open for rent to any member to hold receptions, parties and other events. We have two halls available, the upstairs has a capacity of 325 people and the downstairs has a capacity of 120 people. A security deposit of \$250.00 is required to hold a date and will be refunded if no damages are found, after the event. The upstairs hall rate for Friday and Saturday is \$400.00 each night and the downstairs hall is \$300.00 per night. If you prefer a Sunday rental, both halls are \$100.00 each. If you are interested in a specific date please call the union hall for availability 419-473-2854.

## What is VEBA?

VEBA stands for Voluntary Employee Beneficiary Association which is a medical benefits trust for the UAW retired members.

### History of the trust

The Trust was established as a result of the 2007 collective bargaining agreements between the UAW and the three auto companies.

Under the agreements, retiree health care liabilities were transferred to a new independent Voluntary Employee Beneficiary Association (VEBA), which is composed of three separate Plans (GM, Ford and Chrysler).

When the Trust launched in January 2010, it became the largest non-governmental purchaser of retiree health care in the United States, covering over 860,000 members. Since then, the Trust has focused on retiree health care and making benefit changes to ensure the continuation of the funds.

### Checks and Balances

The Trust is governed by an 11-member board of trustees (the Committee). Five of the committee members are appointed by the UAW; the other six are independent of the UAW and were originally approved by the federal district court as part of the class action settlements.

On a day-to-day basis, the Trust is run by a staff of dedicated professionals. Find out more about current committee members and senior leadership staff on the Leadership page.

### Why this is important

The VEBA will cover you when you retire and has a different coverage than your current health insurance plan.

Whether you are retiring next month or thirty years from now you should always understand the impact on your finances for post-retirement health care.

The benefits provided in this plan are based on the amount in the fund, the amount of members in the program and the cost of services provided.

### Benefits

- For the members this protects their post-retirement healthcare with a defined contribution that is protected against a company bankruptcy.
- For the company this reduced their legacy costs which provides higher profits that leads to higher profit sharing.

**Social Security News****Reaching Retirement Age? Here's What You Need to Know**

Every birthday deserves celebration, but some seem a little more special than others. Think of a baby's first birthday. Sweet 16. The "Big 4-0." Then, before

you know it, along comes 65. This last milestone is especially important to retirees. For nearly half a century, American workers looked to 65 as the age at which they could stop working and finally reap their full retirement benefits under the Social Security Act of 1935.

Today, however, the full retirement

age is now 66 or 67, depending on when you were born. In 1983, Congress changed the law to increase the retirement age gradually over a 22-year period, citing improvements in the health of older people and increases in average life expectancy. To find out your full retirement age, visit [www.socialsecurity.gov/planners/retire/ageincrease.html](http://www.socialsecurity.gov/planners/retire/ageincrease.html).

If you've contributed enough to the Social Security system through payroll taxes, you still can claim your retirement benefits at 65 — or 62, 63, or 64, for that matter — but your monthly payments will be permanently reduced. For help deciding which age is right for

you to start receiving Social Security retirement benefits, read, "*When to Start Receiving Retirement Benefits*" at [www.socialsecurity.gov/pubs/EN-05-10147.pdf](http://www.socialsecurity.gov/pubs/EN-05-10147.pdf).

We have also made applying for benefits easier than ever. You can do it online! To apply for benefits, please go to [www.socialsecurity.gov/apply-forbenefits](http://www.socialsecurity.gov/apply-forbenefits).

That said, age 65 should still factor in prominently as you prepare for retirement and a stable financial future, because that's when most American workers first become eligible for Medicare health insurance coverage. To see if you've earned enough credits through work to qualify for Medicare at age 65, view your *Social Security Statement* online using your personal *my Social Security* account. Create or log on to your account at [www.socialsecurity.gov/myaccount](http://www.socialsecurity.gov/myaccount).

If you're already receiving Social Security benefits before age 65, we'll automatically enroll you in Medicare Part A (hospital insurance) and Medicare Part B (supplemental medical insurance) effective the first day of the month you turn 65. Watch your mailbox a few months before your birthday for your Medicare card. Otherwise, three months before your 65<sup>th</sup> birthday, you can apply for Medicare Parts A and B online at [www.socialsecurity.gov/applyforbenefits](http://www.socialsecurity.gov/applyforbenefits).

Your Initial Enrollment Period for Medicare starts three months before your 65<sup>th</sup> birthday month and continues for three months after. 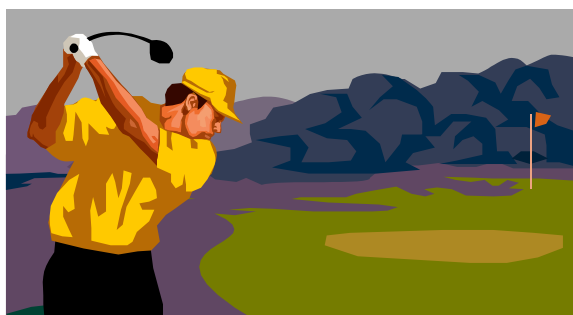

# Republicans make good on bad promises

UAW News – It has never been more difficult to keep up with national politics. Between ongoing investigations, tweets, tensions with foreign powers, and disputes over immigration, taxes and health care policy, it is easy to lose sight of what matters in our daily lives: decisions that impact our quality of life and paychecks.

The Republican-controlled Congress and White House appointees hurt workers' rights by gutting rules and regulations they claim are unnecessary and bad for business. These measures lay siege to working people's ability to organize and bargain for fair wages and safe working conditions.

Last year, the Republican Congress passed a law that ends the requirement holding employers financially responsible for maintaining accurate records of work-related injury and illness data for a reasonable amount of time. This law takes us backward by making it harder to detect health risks from breathing in toxins and repetitive injuries. If not repealed, it will certainly lead to more injuries and even deaths on the job.

The administration is gutting a rule allowing white-collar workers to be paid more for overtime by limiting eligibility for overtime to workers who earn \$913 per week or less. The existing overtime rule benefitted millions, including thousands of UAW members who work in colleges and universities. The administration is also moving to roll back rules allowing workers to keep their tips. According to the Economic Policy Institute, employers could legally pocket \$5.8 billion in tips each year. The impact could be widespread as workers who regularly receive tips include thousands of UAW members working in casinos as restaurant workers and as delivery people.

President Trump's selections to serve on the National Labor Relations Board (NLRB), William Emanuel and Marvin Kaplan, have long track records of opposing workers and siding with corporations. Both were confirmed by the Senate with Republican support only. Once in place, they immediately took actions that blatantly favored unscrupulous employers over workers. Their decisions make organizing even more difficult, fair elections more tenuous, and the boss's interference and threats without accountability easier. The NLRB's new pro-management general counsel, Peter Robb, hastily threw out a case put forward by our Honeywell members in Indiana and New York who were locked out for 10 months.

To make matters worse, the NLRB is giving more power to board members in Washington and less to career civil servants all over the country — an ominous sign for workers seeking to organize and collectively bargain. The

Republican-controlled Congress supports these rollbacks, so it is an uphill battle to stop them.

In our system of government, nearly all controversial decisions ultimately see their way to federal courts where judges either stop them or let them go forward. President Trump is on pace to eclipse modern presidents with the highest number of judges con-

firmed in his first term. President Trump has confirmed a record 23 judges in his first year as president. President Obama confirmed three and George W. Bush confirmed six. Nearly all these judges have extensive anti-worker records and will have the opportunity to affect the lives of the millions of American workers for many years to come as federal judges have lifetime

appointments. Senate Republicans also want to pass the Tribal Labor Sovereignty Act. This bill would directly harm our members at Foxwoods Casino in Connecticut and hundreds of thousands of other workers by eliminating federal rights for commercial enterprises on tribal lands like casinos, mines and resorts. Anti-worker groups, like the U.S. Chamber of Com-

merce, have worked to weaken collective bargaining rights and organized labor. If successful, this would be the first time since the late 1940s that Congress acted to take away worker rights.

So, what can we do about it? We must insist that elected officials listen to us or pay dearly at the ballot box this November.

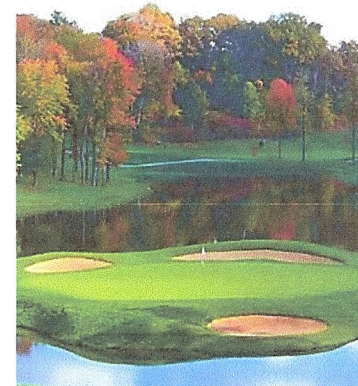

## First May Day May 1, 1886

UAW News – On a spring Saturday on May 1, 1886, workers at 13,000 businesses across America took a stand against dangerous work and low wages, and for an eight-hour work-day.

An estimated 300,000 to a half million workers, many of them immigrants, rallied and paraded through city centers in a general strike to demand an end to unsafe factory jobs with high death rates and little pay while corporations raked in booming profits.

They also were encouraged by the growing labor movement and populist politics sweeping the nation as immigrants poured into the U.S. looking for a better life and found only backbreaking exploitation in dirty, unsafe factories.

Power brokers took notice of the show of force that day and, while it would take decades for workers to have true rights and safety on the job, that first May Day was a milestone for unity and justice for workers everywhere.

May Day would become an annual tradition that would lead to an International Workers Day holiday celebrated throughout the world today.

Thanks to Greenwood Elementary, Meijer Alexis Road, Glass City Federal Credit Union, Citizens Bank and many others.

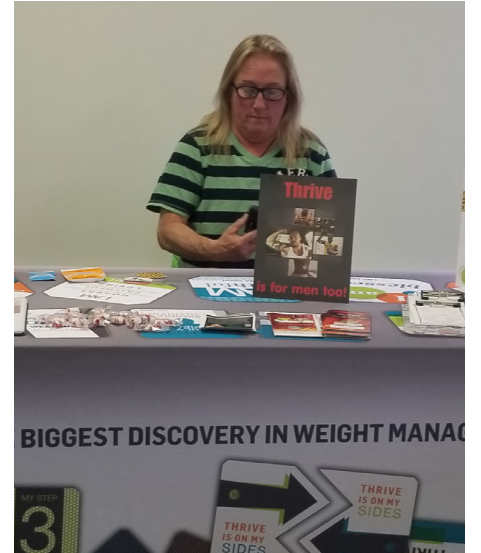
