# Local 14 shows Union's spirit as November 6 election nears

The Labor Day Parade not only marks the start of the Fall season, it also sets the tone for the final two months of the political season. As Local 14 members showed their spirit of Solidarity during the parade, the union's Community Action Program (CAP) was already at work promoting candidates for national, state, and local offices who support working families.

In his message to members in this issue of the Union Progress, Local 14 President Dennis Earl said, "I am asking every member to get out and vote and take all of your family members and friends of voting age with you. The only way we can change the direction of this country is at the ballot box."

The UAW is supporting a full slate of candidates in Ohio and Michigan (see Ohio endorsement list at left and Michigan endorsement lists on Page 2.)

Earl noted that these candidates have proven track records of working with working people to improve working conditions, wages, benefits, safety, and retirement.

"In Ohio, we're proud to support Sherrod Brown for U.S. Senate, Marcy Kaptur for U.S. House of Representatives, Richard Cordray and Betty Sutton for Governor and Lt. Governor, and all the other candidates listed," he said.

In Michigan we have a long list of endorsed candidates including Debbie Stabenow for U.S. Senate, Gretchen Whitmer for Michigan Governor, and a host of candidates for U.S. House of Representatives, statewide offices, and local contests. (See Page 2).

While we're not telling you how to vote, we are recommending these candidates because they support us, regardless of party affiliation., he said.

The union has been working steadily to support endorsed candidates. Local 14 members have done so in a variety of ways.

We are reaching out to our members and their families and friends by texting, phone calls, door to door labor walks and leaflets at the factory gates. UAW members have been manning phone banks and contacting members to urge them to vote either early or on Nov. 6.

Last week, UAW members had a chance to talk with area candidates at a "Meet the Candidates Night" here in Toledo, and our UAW CAP Councils have been performing similar duties in Ohio, Michigan, and Indiana.

The importance of this election cannot be overstated, Earl said. The UAW and working families are under constant attack by wealthy and powerful adversaries who promote policies and vote for specific pieces of legislation which support the desires of the top 1 percent (or one tenth of 1 percent) at the expense of the vast majority of Americans. "We have the chance to start to turn that around on Nov. 6 if we all get out and vote."

All active and retired members of Local 14 are eligible to attend the Amalgamated Meetings. These meetings are held 4 times a year at 9 a.m. on the 4th Sunday of January, April, July, and October.

### Why Right to Work is wrong!

"In our glorious fight for civil rights, we must guard against being fooled by false slogans, such as 'right-to-work.' It provides no 'rights' and no 'works.' Its purpose is to destroy labor unions and the freedom of collective bargaining.... We demand this fraud be stopped." – Martin Luther King Jr.

All workers benefit from unions, because unions set pay standards and workplace protections. Union members — workers like you — benefit most from the union's collective bargaining power to negotiate with employers on their behalf. This basic right gives you as a union member more power than if you tried to negotiate as an individual.

#### Why this is currently important

As it hears Janus v. American Federation of State, County, and Municipal Employees, Council 31, the Supreme Court will decide whether public-sector unionism violates the First Amendment rights of workers who refuse to join unions. The case will be one of America's most consequential for government labor—management relations. If the Court rules for the plaintiffs, state- and local-government workers in 22 states will no longer have to belong or pay union dues as a condition of employment. This would ultimately diminish the benefits the union negotiates.

#### With unions workers receive.

- Better Wages
- · More Access to Benefits
- Job Security
- Better Safety
- · Strength in Numbers
- Seniority

All of these benefits and gains have a cost associated with them. There is no free lunch. What this Supreme Court ruling will do if it votes against unions would erode our bargaining power to get workers a better deal. This would open the door for free riders (workers that reap the reward of belonging to a union without paying union dues). This is also why our elections have consequences.

# Why we should buy what we make.

- The obvious reason is job security; why would we support people who do the same job as us while potentially putting ourselves out of work?
- Perception is also reality. When people drive by our facility and see foreign and non GM vehicles, that says we don't believe in our own products enough to purchase them ourselves so why should they?

That is the same for our neighbors when they see us not have the vehicles we produce in our own driveways.

• When you buy our products you also support our communities. We provide a lot of tax dollars that fund the schools our kids go to, police, fire and rescue, and our hospitals because of our health insurance.

Although our foreign competition makes vehicles with a lot of U.S. made components their profits go back overseas.

- We know our products are expensive but you don't have to buy a new vehicle if it's out of your price range, buying a used vehicle is good also! Buying a used vehicle helps raise the resale value of our products and that helps with the sales to the initial buyer,
- Profit sharing is connected to this also! When we buy our own vehicles we contribute to our own best interest. We increase our compensation.
- Lastly, this is about JOB SECURITY! Are we going to support ourselves or other people that do the same job that we do?

# **Financial Secretary-Treasurer**

]The Merrill Lynch account balance on 9/30/18 was \$2,841,406.13

The book value on 9/30/18 was \$2,773,330.82 and the actual value was \$68,075.31 more than we can report on the financial statement. This is our unrealized gain and if we cashed in our account at the end of September our pay out would be \$2,841,406.13.

Our light bill for the month of September was \$1,117.16 and the gas bill was \$162.96. Last year the Fall/Winter monthly light bill averaged \$1,300.00 and the gas cost was an average of \$800.00 per month.

The UAW Local 14 dues paying cards are ready and I will start distributing these to members this week by departments. Please call the hall if you do not receive your card by the end of October.

The Richard T. Gosser Scholarship began in 1962 and has awarded over two million dollars in scholarships to 344 students of Region 2-B UAW members.

Our six month elevator inspection was done and no violations or issues were found.

I will continue to keep you informed on the monthly hall rentals at UAW Local 14. In the month of

September the upstairs hall was rented 12 times and the downstairs was rented 10 times.

The Local 14 website has been updated with many new items to keep the membership informed. The committees that represent Local 14 can be found on our site with their upcoming events. The Union Progress can be viewed and many other important events can be found here. Our website address is: www.uawlocal14.org

The last day to rent a park shelter at the Oscar Bunch Park or a tent was September 24, 2018. If you would like to rent in 2019 we start the rental process February 1, 2019. Thanks for your 2018 rentals.

We currently have a contract with Republic Services to remove our trash at a cost of \$325.00 per month, this contract expires on 10/31/18. I received lower rates from local competitors so I was able to negotiate a new three year contract with Republic Services for \$215.00 a month. This will be a savings of over \$1,300 per year. Republic Services is a local union contractor.

Local 14 halls can be rented all year round to any member for receptions, parties and other family

events. We have two halls available, the upstairs has a capacity of 325 people and the downstairs has a capacity of 120 people. A security deposit of \$250.00 dollars is required to hold a date and will be refunded if no damages are found and the contract rules are followed. The upstairs hall rate for Friday and Saturday is \$400.00 each night and the downstairs hall is \$300.00 per night. If you prefer a Sunday rental, both halls are \$100.00 each.

Even when that mission is to spend an arduous year in a hospital recovering from being blown up, badly burned, and shot multiple times. Greg shared the leadership principles and values he learned as a member of an A-Team. He gave us ideas on how to apply Special Forces strategies to our personal and business lives.

Greg also wrote a book called Conquer Anything. This is a special-forces book, but even more, it is a leadership book designed to help each of us achieve the highest goals possible in our professional and private lives.

UAW members are the fabric of America and we represent the true Americans. We have made sacrifices for our jobs, we hold up the economy and this great American life we live.

Our strength is made of love and compassion. We are true leaders of importance for safety; union members are four times safer than non-union.

We are the leaders that uphold and make the ones around us strong and help us survive as a union. We are asked to love one another while society is too busy hating.

# **Chaplaincy Committee at Regional Council Meeting**

At the Region 2B Advisory Council and Leadership Meeting Oct. 15 and 16, we started our Chaplaincy meeting with a word of introductions and a word of prayer.

Kelvin Harlemon stepped down as the Region 2B Chaplaincy Coordinator. Angela Turner has been placed into that position until the next election cycle. We were very pleased to have her leading our meeting.

An introduction was made of our regional service representatives and Jerry Carson, the UAW International Chaplaincy Representative. Jerry Carson then gave us the International Chaplaincy Report. A total of 54 UAW Officers, Board Members, and regional coordinators completed the Certification and Ordination Training for Chaplains. Region 2B received the UAW Traveling Chaplaincy Trophy for the fourth consecutive year, for sending the greatest number of delegates to the annual conference at Black Lake. Information was given about a weekly chaplain conference call for all chaplains and committee members to join in on. Chaplains were also reminded to continue or begin to use the LUIS reporting system to track hours and contacts. (I personally have to get information about this system. and begin to use it.) The annual Black Lake Conference dates are set, June 2 - 9, 2019, and we are to expect the call letters to come out approximately 3 months prior.

As a group, we discussed our specific challenges and opportunities at each of our locals, we then shared with each other suggestions and best practices so that together we can rise. Coordinator Angela Turner shared with us some of her specific goals that she has set for the Region, and then encouraged us to each set our own goals, 3 or 4, that we would like to work on within our own locals.

Region 2B Director Rich Rankin, brought before our council a new proposed bylaws update. Previously, the various councils and committees had separate bylaws, many of which did not coincide with those of other committees. The new proposed bylaws were uniform across all committees. other than a few specifics that were set based on the nature of each committee. The proposed bylaw listed the Chaplaincy Councils mission as "to reach out to and assist UAW members and communities by putting into practice our motto, CARING IN THE WORKPLACE.

We will achieve this by: Providing intentional effective Spiritual care and unity to all its members, and allowing all members to express their faith or lack of faith; by being inclusive of all faith traditions in love. It is the Council's intent/goal to provide practical service in times of need, to make help possible" (Article II, E). The proposed new bylaws were then brought before the council for confirmation. Bylaws passed unanimously and were adopted.

The Monday meetings were then closed in prayer and fellowship.

On Tuesday, the meeting was called to order by Director Rankin, and Presentation of colors was made by the Veteran's Advisory Council, including Local 14's own Peggy McKnight. Invocation was given by Angela Turner of the Region 2B Chaplaincy Council, and the day's agenda was reviewed by Director Rankin. Invited Speaker, Greg Stube, former Green Beret, gave a fantastic talk about his time in combat and the importance of Unity and true effective Leadership. It stated that "It's never the leader that is great, but rather it is always the team that is great", reminding us that no matter what leadership role we may be in, to be great requires the team to be great. He spent a time pointing out that none of us is any better than another and that we need to remember to not think any more highly of ourselves than others because of that, saying "We are born slobbering on ourselves, and hopefully we live long enough to be slobbering on ourselves again".

One of his other points was that there are two types of people in the world, those that think they are tough, and those that have been tested and know that they are NOT. The main takeaway from his talk was that we are nothing without our team, and a great leader has to remember that. We we are all just "turds," and have to rely on others to get through any and all adversity.

Director Rankin gave a short talk reminding everyone that we need to vote, and that what is gained at the bargaining table can be lost at the ballot box. He also spoke on doing things that work to accomplish our goals, and to remember to work with others who have been through the situations, and to work on three or four things on the list, not the whole list at once. He said, "Be a leader, Accept Responsibility. Make good decisions. (BAM)."

We had a short presentation by

Erin Scott, of LEAD Ohio, a group that helps teach those who wish to run for office of any kind within Ohio how to do all of the important parts of preparing for and winning an election. They have regular classes that they do to teach any prospective candidate the important parts of the election cycle. They have a fantastic program that works with all local and state level elections to help candidates be prepared for campaigning. Ms. Scott encouraged anyone that is even considering running for office in Ohio to get in touch with LEAD Ohio and find a class that was right for the candidate and his situation.

We finished with a report by the CAP representatives. We were again reminded to pay attention to the election cycle and ballot according to those who will support our specific values. Meeting was then adjourned





I went to Black Lake in August. I took the class of understanding LGBTQ.It was a really great and informative class. I learned that in a majority of states (28), it is legal to fire a worker for being lesbian, gay, bisexual, or transgender. Pride at Work supports a federal ban on discrimination in the workplace based on sexual orientation and gender identity or expression such the Equality Act. An inclusive union contract (one that includes non-discrimination on the basis of sexual orientation. and gender or expression can serve as protection for LGBTQ working people and these union contracts is enforceable in every state. LG-BTQ people face various forms of discrimination in the workplace.  $Union \, non-discrimination \, clauses \\ protect \, from:$ 

- Firing
- •Denying promotions or not hiring
- Verbal, physical, and sexual harassment
- •Unsafe or inaccessible bathrooms
- Inadequate health care cover-
- Benefits sharing based on outdated definitions of family.

  - · Delays in resolving conflicts

## How unions help women

Collective bargaining agreements ensure that all workers get the same pay for the same work regardless of gender. Women in unions make more than nonunion women, especially Hispanic women who earn roughly \$739 per week as a union member rather than \$520 per week for a nonunion, Hispanic woman. The percentage of women in unions continues to grow with women now comprising about half all union members.

### Here are 10 reasons why being union helps women:

- 1. Union women made more money than their nonunion counterparts across the country.
- 2. Being in a union means you'll make more money. Women who worked full time and belonged to a union earned a median weekly wage of \$899. If they weren't in a union they

- made almost 31 percent less or \$687 per week.
- 3. The wage gap in 32 states between women who are in a union and those who aren't is big enough to cover the cost of full-time child care for an infant.
- 4. As of 2014, almost half of all U.S. union members were women. 6.6 million of the 14.6 million members in the U.S. in 2014 were women.
- 5. Women have increased their percentage of union membership in the U.S. In 1994 women were 39.7 percent of union members. In 2004 that increased to 42.6 percent. Ten years later in 2014 women were 45.5 percent of all union members.
- 6. Wyoming was the state with the largest wage advantage for union workers in 2014. There, the average female union member made 53 percent more than nonunion women in Wyoming.

- 7. Union women had the lowest wage advantage (4.5 percent) in Washington, D.C. But D.C. women make the highest weekly wages in the country regardless of union membership.
- 8. Hispanic women have the greatest wage advantage with union membership when compared to nonunion Hispanic women

Hispanic women who belong to unions typically earn \$739 per week while Hispanic women who don't belong to a union make \$520 a week.

- 9. A large share of union women have pension plans (74.1 percent) compared to nonunion women (42.3 percent).
- 10. Union membership makes a huge difference in health care coverage. 76.6 percent of union women have health care coverage compared to 51.4 percent of nonunion women with coverage.

# Be the first to know: Online COLA notices

We are constantly expanding our online services to give you freedom and control when doing business with us. Our new online cost-of-living adjustment (COLA) notices are another example of our commitment in this area. Soon, you'll be the first to know your new benefit amount! Later this year, we will post the Social Security COLA notices online for retirement, survivors, and disability beneficiaries with a my Social Security account. The COLA announcement usually occurs in October, but final benefit amounts won't be calculated and available until December, when we send COLA notices that contain the benefit amount for the next

UAW News - Under the International Union, UAW Constitution, our union is required to provide a strong and relevant member education program. Member education is so important to the UAW that a portion of every member's dues dollar is allocated to education to grow member knowledge, understanding and strength.

Members are essential to having a relevant educational program and we hope you have a chance to attend UAW local union, regional, and national educational offerings to access new information and share your life experiences in a rewarding learning environment.

These COLA notices will now be available to view and save via the Message Center inside my Social Security. The Message Center is a secure, convenient portal where you can receive sensitive communications we don't send through email or text.

This year, you will still receive your COLA notice by mail. In the

future, you will be able to choose whether you receive your notice online instead of on paper.

Online notices will not be available to representative payees, individuals with foreign mailing addresses, or those who pay higher Medicare premiums due to their income. We plan to expand the availability of COLA notices to additional online customers in the future.

Remember, our services are always free of charge. No government agency or reputable company will solicit your personal information by email or request advanced fees for services in the form of wire transfers or gift cards. Avoid falling victim to fraudulent internet "phishing" schemes by not revealing personal information, selecting malicious links, or opening malicious attachments. You can learn
